This document outlines ROAM enhancements effective August 2014.

Redesigned User Interface

The redesigned user interface enhancements include style changes to the logo, headers, buttons, grids, and improvements to system navigation.

New Logo

The new logo was designed to symbolize our singular focus on you and our commitment to improve global communications and consistency in messaging.



Updated Headers

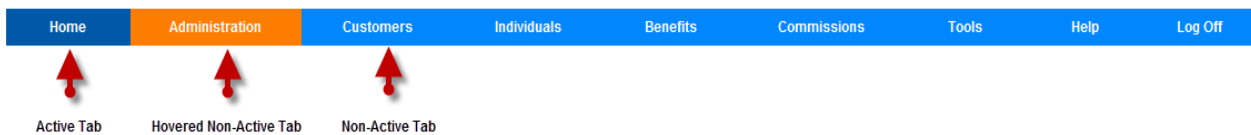
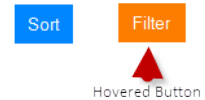
The color scheme for all page headers, containing the new ROAM logo and corporate logo, are now displayed in a white backdrop.



Redesigned Button and Tab Controls

The following changes are available to improve button and tab controls:

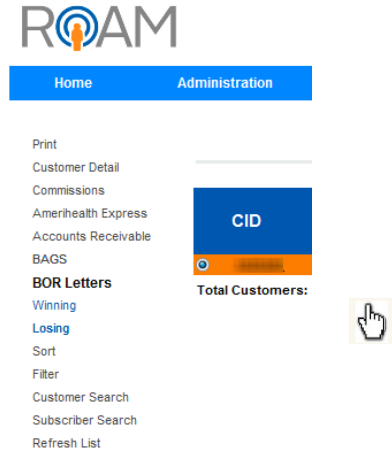
- The redesigned page buttons are now displayed in white text with an orange background. When hovered, these controls are displayed in white text with a bright blue background.
- In the active state, the tab controls in the Menu Bar are displayed in white text with a dark blue background.
- In the non-active state, the tab controls are displayed in white text with a bright blue background. When hovered, these controls are displayed in white text with an orange background.



Improved Navigation

The following changes are available to improve system navigation:

- Underlines are no longer used for hyperlinks in the Navigation Menu. Instead, the cursor tool hand image is used as a visual indicator when hovering over links.
- Hyperlinks in the Navigation Menu no longer change colors when a link is hovered. Instead, all links are displayed in standard black text.
- Indentations and expansion arrows are no longer used to indicate subcategories. Instead, major category headings are displayed in bold-faced with a black font color; and subcategories are listed below the major category headings with a blue font color.



Enhanced Grids

The following global enhancements are made to the grid design:

- An alternating white and gray color scheme is used to separate rows.
- Selected rows are highlighted in orange.
